## **OVERVIEW**

This memorandum is prompted by the outcome of this year's State budget process and is intended to summarize the status of factfinding as it pertains to PERB at this time.

The outcome this year involves the elimination of PERB's funding for factfinding—\$85,000—but does not also involve the corresponding statutory change identified as necessary to accompany the elimination of such funds. In other words, PERB's funding specified for factfinding was eliminated but its statutory obligation to pay for factfinding was not.

Historically, the amount of money spent by PERB for factfinding services (i.e., the daily rate for panel chairpersons) has been set by the Board itself; such action requires a public Board meeting.

PERB is required under EERA and HEERA to select and bear the costs of the services of the panel chairperson, including per diem fees, if any, and actual and necessary travel and subsistence. (Gov. Code, §§ 3548.1 et seq. and 3591 et seq.) EERA expressly provides an exception to the requirement that PERB bear the costs of the factfinding panel chairperson where the parties exercise their right, under EERA section 3548.1(b), to "mutually agree upon a person to serve as chairperson in lieu of the person selected by the [B]oard." HEERA is silent on this subject.

#### PERB'S FACTFINDING COSTS & DATA

The costs of factfinding are largely beyond PERB's control. In addition, "costs" include not only the services of the factfinding chairperson (i.e., the daily rate), but also any per diem and necessary travel and subsistence of the chairperson.

## RECENT & CURRENT BUDGET ACTIONS REGARDING FACTFINDING

For 2007-08, PERB received approval through the State budget process to augment its budget in the amount of \$85,000 specifically for factfinding expenditures. The total costs incurred by PERB through June 30, 2008, however, exceeded the appropriated amount—totaling \$97,494—even though PERB staff took action as of June 11, 2008 to cap each factfinding contract at \$2,000.

For 2008-09, PERB's budget was reduced in part by eliminating the \$85,000 previously specified for factfinding expenditures. Significantly, even though the need was identified during the 2008-09 budget process to eliminate from EERA and HEERA the requirement that PERB bear the costs of panel chairpersons (since PERB's funding for these services was to be eliminated), that piece of the elimination was not approved by the Legislature.
