ORDER

The San Francisco Bay Area Certificated Educators and Professional Associates, Teamsters Local 856 has appealed the decision of the San Francisco Regional Director not to conduct representation elections in the two appropriate units established in the above-captioned case. The appellant asked that the elections be conducted in these units subject to challenges to the ballots cast by the employees whose positions are the subject matter of exceptions to the hearing officer's proposed decision in this case. The regional director ruled that the elections would not proceed until these exceptions were resolved by the Board itself.

The exceptions to the unit determination decision having been resolved by this Board in the Franklin-McKinley School District, (October 26, 1979) PERB Decision No. 108, the appeal herein, filed by the San Francisco Bay Area Certificated Educators and Professional Associates, Teamsters Local #856, is now moot and is therefore dismissed.


On April 13, 1979, the regional office received a request by the San Francisco Bay Area Certificated Educators and Professional Associates, Teamsters Local #856, that an election be directed in two supervisory units of the Franklin-McKinley School District.

As you are aware, a PERB Hearing Officer issued a proposed representation decision on March 22, 1979. The decision established two supervisory units--one classified and one certificated. On April 6, 1979, the District filed exceptions to that decision, thereby preventing the decision from becoming final.

Were the parties willing to enter into a consent election agreement, we could possibly deal with the remaining disputed positions through the use of challenge ballots. The District, however, opposes the election until a final unit determination order is issued. Absent the consent of all parties to the election, I feel I have no authority to direct an election when a unit dispute still exists. I am, therefore, denying the request to conduct representation elections in the supervisory units of the Franklin-McKinley School District.

An appeal of this decision may be made to the Board itself within 10 calendar days of service of this letter by filing a statement of the facts upon which the appeal is based with the Executive Assistant to the Board at 923 12th Street, Suite 201, Sacramento CA 95814. Copies of any appeal must be concurrently served upon all parties and the San Francisco Regional Office. Proof of service of the appeal must be filed with the Executive Assistant.
