On March 24, 1980, the following documents were received by this office:

- 1) A decertification petition pursuant to PERB Regulation 33240 from Service Employees International Union, Local 614 for a unit of office, technical and para-professional employees (SF-D-66, R-394);
- 2) A decertification petition pursuant to PERB Regulation 33240 from International Union of Operating Engineers, Stationary Local No. 39, AFL-CIO for a unit of operations and support services employees (SF-D-67, R-394);
- 3) A request for recognition pursuant to PERB Regulation 33050 from International Union of Operating Engineers, Stationary Local No. 39 and Service Employees International Union, Local 614 for the established unit of all classified employees (SF-R-394-1);
- 4) A request for recognition pursuant to PERB Regulation 33050 from International Union of Operating Engineers, Stationary Local No. 39 for a unit of operations and support services employees (SF-R-394X); and,

- 5) A decertification petition pursuant to PERB Regulation 33240 from International Union of Operating Engineers, Stationary Local No. 39 and Service Employees International Union, Local 614 for the established unit of all classified employees (SF-D-57, R-394).

International Union of Operating Engineers, Stationary Local No. 39 and/or Service Employees International Union Local 614 indicated in the various decertification petitions and/or requests for recognition that:

- 1) the established classified unit in the Solano Community College District is a unit consisting of all classified employees;
- 2) California School Employees Association and its Chapter #211 was recognized on or about July 1, 1977 (our records show that CSEA was certified on October 3, 1977);
- 3) A written agreement currently exists between the exclusive representative and the employer; and,
- 4) the expiration date of that agreement is June 30, 1980.

Review of the various decertification petitions and requests for recognition has resulted in the administrative determination that SF-D-66 (R-394), SF-D-67 (R-394) and SF-R-394-1 should be dismissed since they have been improperly filed. In that both SF-D-66 and SF-D-67 seek to carve out new units from the established unit of all classified employees, the petitions should have been filed as requests for recognition pursuant to PERB Regulation 33050. SF-R-394-1 is also improperly filed because it requests recognition for an established unit which has an exclusive representative in place. This request should have been filed as a decertification petition pursuant to PERB Regulation 33240.

This office will proceed with both SF-R-394X and SF-D-57 since both have been properly filed.

An appeal of this decision may be made to the Board itself within ten (10) calendar days of service of this letter by filing a statement of the facts upon which the appeal is based with the Executive Assistant to the Board at 923 12th Street, Suite 201, Sacramento, California 95814. Copies of any appeal must be concurrently served upon all parties and the San Francisco Regional Office. Proof of service of the appeal must be filed with the Executive Assistant.
