DECISION

This case is before the Public Employment Relations Board (hereafter PERB or Board) on an appeal by the Atascadero Unified School District to the attached determination by the executive assistant to the Board rejecting its response to exceptions in the above-captioned case because said response was not timely filed. PERB rules governing the filing of such pleadings are clear.¹ Appellant has not demonstrated the

existence of extraordinary circumstances which would justify the late filing, as required by PERB rule 32133.2

ORDER

The Board affirms the determination of the executive assistant to the Board and DENIES the appeal.

The response shall be filed with the Executive Assistant to the Board. Service and proof of service of these documents pursuant to section 32140 are required.
